**Financial Report** - Treasurer Ruth Hackett introduced our Auditor, Jeremy Childs of Childs Chanton Accountants of Castlegar. Copies of the audit were available to members who wished a copy. Jeremy presented the Audited Financial Statements to March 31, 2024 to the membership in a clear and comprehensive report.

### **Election of Board**

Sally Mackenzie conducted the election of Board members. She informed the meeting that our constitution allows a minimum of 5 and a maximum of 12 members on the Board. We conduct a balloted election to demonstrate that Board members have the confidence of the membership by each securing at least 50% of the vote. If there are nominations from the floor they would be for a 1-year term. A balloting committee of Madeleine Perriere and Julian Ross was named.

Sarah Walsh gave the report of the Nominating Committee of the Board nominating incumbents, Ruth Hackett, Bob Inwood, Sam Simpson and Kathy Hartman and also new Board nominees Ned Johnson and Therin Rhaintre. All positions are for 2-year terms with the exception of a 1-year term for Sam Simpson.

Sally called for nominations from the floor three times but none were received. Nominated individuals were introduced and written bios for all were provided at the meeting. Ned Johnson introduced himself to the membership.

The Balloting Committee reported that all nominees had received more than 50% of the vote and all six were declared elected.
